\$500 Fine

12 months license suspension

1st Offense

Not less than 90 days in jail

\$1,000 Fine

12 months license suspension

2nd Offense

Misdemeanor of the third degree

Not less than 6 months in jail

\$2,500 Fine

12 months license suspension

3rd or Subsequent

Misdemeanor of the first degree

Not less than 2 years in jail

\$5,000 Fine

12 months license suspension

12 months license suspension

2nd Offense

Misdemeanor of the third degree

60 days in jail

120 days Electronic Monitoring @ \$12 per day

\$2,500 Fine

12 months license suspension

3rd or Subsequent

Misdemeanor of the first degree
